

# **Application – 2015 Films4Families Jury**

## What is a film jury?

At film festivals around the world, a selection of accomplished filmmakers and other film professionals are selected to watch a series of films and award one as the best film in the program. At SIFF 2015, seven young adults will be selected to award the Youth Jury Award for Best Films4Families Feature.

### Jury Requirements and Benefits:

- Films4Familes Jurors must be between ages 8-12. (Older students may apply for FutureWave jury.)
- Free admission for a juror and one parent/guardian to see all six films in the Films4Familes program at SIFF 2015. (Each film plays at least twice, during the course of the Festival.)
- Meet at the SIFF Film Center following the final screening (expecting afternoon of June 6, 2015) to deliberate the best film in the program and to celebrate the Films4Families Jury.
- All (7) representatives from the jury and a parent/guardian are invited to attend and present the winner at the Golden Space Needle Awards Breakfast tentatively scheduled for 9:00AM on June 7.
- Free yearlong SIFF Films4Familes membership.

  - o (2) admit-one vouchers to the Festival
  - o Discounted tickets at SIFF Cinema and the Festival
  - Early Bird discounts on Festival tickets and passes
  - Invitations to complimentary film preview screenings

#### To Apply:

Jury members will be expected to attend all eight films in the Films4Familes program at SIFF 2015 and SIFF jury deliberations at the SIFF Film Center. The screening dates and times are not finalized until late April, but most F4F programming happens on weekends between 10:30am-3:00pm. Complete this application with parent signatures, and return by 5:00pm on Thursday, March 26. Applications received after this date will not be considered.
