

Application – 2014 Films4Families Jury

What is a film jury?

At film festivals around the world, a selection of accomplished filmmakers and other film professionals are selected to watch a series of films and award one as the best film in the program. At SIFF 2014, seven youth will be selected to award the Youth Jury Award for Best Films4Families Feature.

Jury Requirements and Benefits:

- Films4Families Jury is reserved for students ages 8 12. (Older students may apply for the FutureWave Jury.)
- Free admission for juror and one parent/guardian to see all six films in the Films4Families program at SIFF 2014. (Each film plays at least twice in the Festival.)
- Meet at the SIFF Film Center following the final screening (expecting afternoon of June 7, 2014) to deliberate the best film in the program and celebrate the Films4Families Jury.
- All seven representatives from the jury and their parent are invited to attend and present the winner at the Golden Space Needle Awards Brunch at 10:00am on June 8.
- Free yearlong SIFF FutureWave membership.
 - Two admit-one vouchers to SIFF Cinema
 - Two admit-one vouchers to the Festival
 - Discounted tickets at SIFF Cinema and the Festival
 - Early bird discounts on Festival tickets and passes
 - Invitations to complimentary film preview screenings

To Apply:

You must be able to attend all seven films in the Films4Families program at SIFF 2014 and SIFF Jury deliberations at the SIFF Film Center. The screening dates and times are not solidified until late April but most F4F programming happens on weekends between 10:00am – 3:00pm, complete this application with parent signatures, and return by 5:00pm on Thursday, March 27. Applications received after this date will not be considered.
