

# **Application – 2018 Films4Families Jury**

#### What is a film jury?

At film festivals around the world, a selection of accomplished filmmakers and other film professionals are selected to watch a series of films and award one as the best film in the program. At SIFF 2018, seven youth will be selected to award the Youth Jury Award for Best Films4Families Feature.

Jury Requirements and Benefits:

- The Films4Families Jury is reserved for students between the ages of 8-12. Films from other countries may have subtitles. (Older students may apply for the FutureWave Jury)
- Free admission for juror and one parent/guardian to see all seven Films4Families features at SIFF 2018 (May 17–June 10). Each film plays twice, and often three times, usually on Saturday and Sunday mornings around 11:00am. Screening dates and times are announced closer to the Festival. Please keep your schedule as clear as possible.
- Pizza party following the final Films4Families screening to deliberate the best film in the program and celebrate the Films4Families Jury. Please hold Saturday, June 9 from 1:00pm-3:00pm for tentative deliberations.
- Representatives from the jury and a chaperone will be invited to present the winner at the Golden Space Needle Awards Brunch scheduled for 9:00am on Sunday, June 10.
- Free yearlong SIFF FutureWave membership.

  - Two vouchers to the Festival
  - Discounted tickets at SIFF Cinema and the Festival
  - Early bird discounts on Festival tickets and passes
  - o Invitations to complimentary film preview screenings

#### To Apply:

Jury members will be expected to attend all seven feature films in the Films4Families program at SIFF 2018 and the SIFF jury deliberations at the close of the Festival. Please double check your calendar that the Festival time period (May 17 – June 10) appears largely free, complete this application with parent signatures, and return by 5:00pm on Friday, March 30. Applications received after this date will not be considered.
