What is a film jury?

At film festivals around the world, a selection of accomplished filmmakers and other film professionals are selected to watch a series of films and award one as the best film in the program. At SIFF 2018, seven young adults will be selected to award the Youth Jury Award for Best FutureWave Feature.

Jury Requirements and Benefits:

- FutureWave Jurors must be between ages 13-18. (Younger students may apply for Films4Families Jury)
- Free admission for juror (and their +1) to see all eight films in the FutureWave Competition Program at SIFF 2018. Each film plays twice, and often three times during the course of the Festival. Screening dates and times are announced closer to the Festival dates. Please keep your schedule as clear as possible.
- Pizza party following the final FutureWave screening to deliberate the best film in the program and celebrate the FutureWave Jury. Please hold Saturday, June 9 from 3:00pm-5:00pm for tentative deliberations.
- Representatives from the jury will be chosen to attend and present the winner at the Golden Space Needle Awards scheduled for 9:00am on Sunday, June 10.
- Free yearlong SIFF FutureWave membership.
 - Two vouchers to SIFF Cinema
 - Two vouchers to the Festival
 - Discounted tickets at SIFF Cinema and the Festival
 - Early bird discounts on Festival tickets and passes
 - Invitations to complimentary film preview screenings

Applying:

Jury members will be expected to attend all eight films in the FutureWave program at SIFF 2018 and the SIFF jury deliberations at the close of the Festival. Please double check your calendar that the Festival time period (May 17 – June 10) appears largely free, complete this application with parent signatures, and return by 5:00pm on Friday, March 30. Applications received after this date will not be considered.
